

pleasure to serve you and your students by continuing to advance your interests to key decision makers and providing services to enhance your career college operations.

The staff of CCO and your Board of Directors look forward to working with you in 2021-2022 to expand on the success we have achieved together over this past year.



OSAP FOR ONLINE STUDENTS




Successfully advocated for permanent OSAP funding for online programs.

Advocacy

RESILIANCE THROUGH ADVERSITY

Thank you to the Board of Directors and its volunteers who dedicated their time to making this year's progress possible. We've made major leaps in our advocacy in just the past few months alone. And their efforts, which have remained a constant even as they face the various challenges of running their own institutions during this time, have progressed our issues and led to significant victories that we have been working towards for several years.

OSAP FUNDING FOR ONLINE PROGRAMS

As we have recently announced to members, the province has approved OSAP funding for online programs. This has been a longstanding ask for the association, and a major step in achieving equitable treatment for our students. Now, colleges will be able to provide high-quality training to more Ontarians



outside of their immediate community. To support this policy change, the province will be implementing "a single program application and approval process that facilitates all methods of delivery – in person, combined and virtual learning – on a permanent basis." This streamlined approval process will also alleviate some of our members concerns about approval periods.

\$53 MILLION IN FUNDING FOR PCC PSW PROGRAMS: PSW CHALLENGE FUND

On April 28, the province also announced \$53 million in funding for career colleges through its PSW Challenge Fund. This fund will benefit at least 80 career colleges providing PSW training across Ontario. This announcement followed a similar announcement that provided funding exclusively to public colleges, leaving our sector at a severe disadvantage. We also recognize that many colleges, including my own, are not eligible for the PSW Challenge Fund due to their non-OSAP status.

Immediately following the PSW funding announcement, we raised our concerns with this decision and requested the province provide rationale that may be

provided to our members:

The government made the decision to use OSAP tools and resources to administer the PSW Challenge Fund so that the program could be launched quickly while helping ensure program accountability, integrity, and efficiency. Ontario is leveraging the OSAP system to:

- Issue grants in the form of electronic payments to schools on students' behalf for tuition and other mandatory fees.
- Issue stipends in the form of electronic payments to schools.
 Schools will pay practicum/placement hosts once the students have started their placements in long-term care homes.
- Confirm student identities, enrolment and undertake other fraud prevention measures.

We understand our members' concerns that this decision excludes many well-established PSW trainers, and we will continue advocating for colleges left out of the funding model.

FUNDING FOR MICRO-CREDENTIALS

I would also like to draw the membership's attention to the \$15 million Micro-Credentials Fund. CCO and its board have been collaborating with the province as it works to respond to regional labour market needs and increase collaboration between the private and public sectors through formal partnerships among postsecondary institutions, training providers and employers.

For those unfamiliar with the term, micro-credentials are rapid training

programs offered by colleges, universities and Indigenous Institutes across the province that can help you get the skills that employers need. They help people retrain and upgrade their skills to find new employment.

The fund will accelerate the development of micro-credentials and expand program offerings to Ontarians. This fund is part of the province's \$59.5 million commitment to support micro-credentials over the next three years. Ontario's investment will help:

- create an online portal to access micro-credential training opportunities
- create new micro-credentials in response to regional labour market needs
- strengthen partnerships between postsecondary institutions, training providers and employers
- launch a public awareness campaign to promote micro-credentials among learners and employers
- support students with financial need to pay for education geared to indemand jobs, through the Ontario Student Assistance Program (OSAP)
- develop a virtual passport that tracks a person's learning experience

Naturally, career colleges are well suited for this program. Those interested in applying for funding must submit a proposal by June 25, 2021, 11:59 p.m. FST

Operations

Delivering exceptional service and resources to members so they can succeed in training Ontario's highly skilled workforce.



CCO HEAD OFFICE OPERATIONS

During the 2020 annual general meeting in October, Career Colleges Ontario outlined the steps it has taken to ensure the safety of its staff and the continued operations of its administrative and financial aid offices. CCO's goal in meeting these objectives were and remains to provide consistent, timely service and support to its member institutions and students as they wade through the turbulent waters of COVID-19.

Since October, the association has continued with its updated processes that allow it to operate at full efficiency in a remote capacity. Internal systems that are critical to enabling staff to serve members have been modernized, printer and fax functions have been brought into a digital space, and teams have been provided the tools needed to set up secure and accessible remote workspaces.



While the modern outfitting of CCO's office has dramatically improved efficiency, member relations, and financial aid operations, it should be viewed exclusively as a testament to the skilled and knowledgeable staff who have adapted to this new technology and refined it to best serve Ontario's career colleges.

To highlight the work of the CCO staff:

FINANCIAL AID OFFICE

Despite the pandemic and its impact on the sector, CCO again saw the largest volume of applications flow through its FAO. The FAO staff, under the leadership of FAO Manager Jodie Cole processed 26,642 applications over the last 12 months. This represents a 6.5% increase in application from the previous period.

Over the past year, our team has transitioned to a completely remote and paperless workspace to maintain our high level of service and fast turn-around times of 48 hours.

CCO is extremely proud of the work and unrivaled expertise of the Financial Aid Office team.

TRANSCRIPT STORAGE (S.T.E.P.S)

Our S.T.E.P.S (Student Transcript Electronic Protection System) continues to flourish. After more than a decade of storing college transcripts, CCO has increased our capacity for service by allowing students to easily request their transcript through our website. CCO also continues to improve the transcript database and upload process with our provider. The strides we have made in our STEPS services are thanks to our Project Coordinator Brianna Cantlon, who discerningly oversee this crucial program for the province's career colleges.

MEMBERSHIP

It is with great enthusiasm that I report the association's membership has grown from 240 to 256 career college campuses since October. I would like to once again welcome our new members and thank them for their support and engagement of the association and the broader career college sector.

In February, CCO launched its new online members application process to replace its paper forms. Thanks to this new process, the association is able to better review the needs of our new members, their operations, and expectations of the association, which ultimately allows us to serve them better.

We have also launched an online fee calculator accessible on our Become a Member page of the website, which allows prospective members to review the cost of membership before they apply.

Our membership program is studiously managed by our Accounts/Membership Officer, Dena Stuart.

SEARCH FOR A NEW CEO

On April 22, the association announced that it has accepted the resignation of its Chief Executive Officer, Christopher Conway.

Chris played a critical role in the association's success since joining the organization in December, 2018. His leadership in government relations, committee work, and staff administration have guided the association to better identify and meet the expectations of CCO members.

Because of his deep-rooted commitment to the career college sector and its members, CCO finds itself in a stronger position to fulfil its mission to advocate for the equitable treatment of career colleges and their students.

To begin its search for a new chief executive officer, the association is engaging a third-party recruitment firm, which will be supported by an external task force consisting of career college professionals and led by former Executive Director Paul Kitchin. The third-party firm and task force will guarantee a transparent and independent candidate selection process.

CCO's board of directors will then interview the candidates that the task force presents. Following these interviews, the board will elect a successful candidate for the position.

Proposed Budgets for 2020 – 2021

Luisa Tanzi, Treasurer presented the proposed budgets for 2020 – 2021 noting any changes from previous years.

Appointment of Auditor for 2020 - 2021

Election of Directors

Proposal to Extend all current Board Members Terms for one year. A vote was held with 96% of the delegates in favour of the proposal. The proposal was approved.

Election

Adrian Sharma, Board Chair reported that there are 3 vacant positions on the board and 6 candidates seeking to fill the vacancies: Carlos Carvalho, CTS College; Dean Tremain, Canadian Business College; Don Thibert, Westervelt College; Mark O'Shaughnessy, Institute of Technical Trades; Muraly

Srinarayanathas, Computek College and Percy Dastur, Academy of Learning College. All candidates were provided 2 minutes to speak.

Adrian then asked if there were any nominations from the floor 3 times with no one nominated.

Following an election for directors, Don Thibert, Mark O'Shaughnessy and Carlos Carvalho were elected to fill the 3 vacant positions on the board.

Annual Report

Chris Conway, CEO reported on the highlights from the Annual Report noting that although it has been an exceptional year the sector appears to be rebounding from the COVID 19 Pandemic. Chris reported examples of this include the increase in OSAP application processing and online training being extended to July 31, 2021. Chris reported that all CCO staff are working successfully from home.

Chris reported that CCO had more than 60 political meetings, many of which were with senior officials to advocate on Post Graduate Work Permit, Delegated Authority, Review of the PCC Act 2005, level playing field for the Second Career program and inclusion in the apprenticeship training program.

Adrian thanked Chris for his presentation and welcomed the 3 new board members. Adrian also thanked Des Soye and Paul Kitchin for their service to the CCO Board who are both stepping down following the AGM.
